In addition, other Board-adopted core curriculum materials were provided to remedy all insufficiencies identified through a survey and other activities at the annual Instructional Materials Hearing at the October 29, 2019 meeting of the Board of Education. All adopted high school instructional materials have been evaluated and determined locally to meet state standards for grades 9-12. Appropriate science laboratory equipment is available for all laboratory science courses.

#### For Elementary and Middle Schools (grades K-8)

The San Francisco Unified School District adopts instructional materials following the cycle of state frameworks and standards, and adopts K-8 materials from the list of standards-aligned materials that have been adopted by the State Board of Education. The district provides sufficient textbooks for all students to use in class and to take home in the core curriculum areas of reading/language arts, mathematics, science, and history/social studies. For 2018-2019, instructional materials were provided for all students in grades K-8. Replacements were provided for core curriculum areas as identified through a survey and other activities preceding the annual Instructional Materials Hearing at the October 29, 2019 meeting of the Board of Education.

#### School Safety Plan - Most Recent Year

The School Safety Plan includes updating and documenting our emergency response procedures and materials, continuing to refine and consistently implement the School Wide Responsibility (Behavior) Plan and the Caring School Community program. We offer 20 hours of district health mandated curriculum focusing on Conflict Resolution and drug refusal skills. It also calls for reinstituting School Spirit activities, and increasing integration activities between the Chinese Bilingual and the General Ed/ELD classes. A schoolwide emergency/disaster plan has been developed and the whole school community is notified of an evacuation, student release and other safety features. We are instating RtI (Response to Interventions) a practice that matches a high quality, evidence based intervention program that meets students needs by frequently monitoring students academic progress based on behavior interventions. Playworks is a comprehensive physical activity program that focuses on physical and healthy play activities for all of students.
